Neighborhood development

The WMATA Northern Bus Garage development on 14th Street is proceeding in its environmental remediation phase. As part of that, WMATA is offering residential and commercial property owners within 200 feet of the site free building inspections, both before and after demolition and/or construction activities. Such owners will be receiving a certified letter in August with information on how they can schedule a free inspection. Anyone with questions about this program can call Jim Ashe at 202-400-1550. DC Health Now Offers At-Home COVID Testing

DC residents who have difficulty leaving home can now receive at-home COVID testing from DC Health. Appointment requests can be made by calling the DC Health COVID Call Center at 855-363-0333. A registered nurse will arrive at the resident's home with both PCR and rapid-antigen testing options and assist with tests.
